Terms and Conditions: Mail this completed application/agreement form and full payment to the information listed above. **IMPORTANT: Your exhibitor space is not guaranteed until full payment is received.** Fee will be deposited upon confirmed booking of the application. Registration fees are not refundable unless we cancel the event due to weather. Space fee is \$25 for 1- 6 ft table in a 6' by 8' space. For a space only (no table) the fee is \$20. Vendors are welcome to bring their own tables. These fees will help defray the costs of advertising and raise money for annual operating costs of the CDWC.

Confirmation/Details: Your application/agreement will be confirmed by email within 2 days of receipt of your payment. Tables are 6' and include a chair. You must provide any other equipment (examples: cart to load/unload, tape, display shelves, bags for your buyers' purchases). Setup will begin at 7:30AM, doors will open at 9AM. There is the ability to set up the night before but arrangements need to be made with Katie in advance. Vendors will be given until 5pm to tear down. Placement, flow and competition will be taken into consideration to provide the best experience for both exhibitors and shoppers. We will try to accommodate special requests, but cannot guarantee.

Your exhibitor space must be staffed at all times. You are fully and solely responsible for any loss or damage to your property by theft, fire or casualty, without exception. You are also responsible for any damage incurred to the facility as a result of or in connection with your operations.

Release from Liability: You are responsible for carrying the appropriate insurance to protect yourself and others. In consideration of the Corps of Discovery Welcome Center permitting you to enter upon and use its property for the purpose of participating in the "I Hate Winter Shopping Blitz" event, you indemnify and hold harmless the CDWC and their agents from any and all bodily injury (including death), loss or property damages caused by, arising out of, related to or associated with the use of the property or the participation in the "I Hate Winter Shopping Blitz" event.
